

## **Noble Federal Credit Union Membership Drive Official Rules and Regulations**

1. No purchase necessary. Promotion takes place during the following “Promotional Period” of August 25, 2025 – November 21, 2025, during branch hours.
2. Employees of Noble Federal Credit Union, the Board of Directors and Supervisory Committee and their immediate families (dependents under IRS definitions) are not eligible to participate.
3. Entrants must be 18 years of age or over on or before the day prior to the start of the Promotional Period.
4. By claiming a prize, winner consents to allow Noble Federal Credit Union the use of their name and photograph in advertising without compensation. Further, by accepting a prize, winner agrees to not assert any claims and agrees to release Noble Federal Credit Union, Board of Directors and Supervisory Committee and third party prize contributors/supplies from any and all liabilities, injuries or damages sustained in connection with the award or use of the prize(s).
5. Winners are solely responsible for reporting winnings and paying all applicable taxes. Noble Federal Credit Union reserves the right to award cash or some other substitute of equal or greater value in lieu of the prizes.
6. Limit: An individual may only participate in the membership drive once and enter into the Cash Cube once.
7. **How to Play:**
  - a. A new membership needs to be established during the Promotional Period at a branch or through the online application found on Noble Federal Credit Union’s website ([www.NobleCU.com](http://www.NobleCU.com)). The new member must not be on an account at Noble Federal Credit Union prior to opening the new membership.
  - b. Upon opening the new membership, the new member will receive a “Ticket” good for one entry into the Cash Cube, located at the Clovis branch at 175 N. Clovis Ave (Clovis Ave and Palo Alto) and can be turned in at one of Noble Federal Credit Union’s Tailgates during a 2025 Fresno State Football home game (no football game tickets or parking are provided as part of the Promotion). Tailgate dates are August 30, 2025, October 4, 2025, October 25, 2025, November 15, 2025, and November 22, 2025. The Ticket provides entrance for the new member and members of their immediate family or household (those living in the home of the new member) to attend a Noble Federal Credit Union Tailgate.
    - i. While in the Cash Cube, the new member agrees to abide by the rules of participation in the Cash Cube, as written on the door of the Cash Cube and described below. Those rules include:
      1. Safety glasses are required for all participants.
      2. While inside the Cash Cube, participants must face the front of the machine and catch vouchers/bills in the air only.
      3. Participants must not trap vouchers/bills against roof, walls, or body, and they cannot bend at the waist or knees to pick up vouchers/bills from the floor.

4. Participants must be escorted by an Attendant upon entering and while exiting the Cash Cube.
    5. Participants must be in good physical condition to participate. Persons with back, neck, knee or joint injury, respiratory problems or who may be pregnant should not participate. If the participant is currently under medical care, a physician should be consulted before entering the Cash Cube.
  - ii. The amount of money the new member grabs will be considered the “Winnings;” up to \$1,000.
  - c. Lost or stolen tickets will not be replaced.
  - d. Tickets are non-transferable and have no cash value.
8. ODDS OF WINNING AN INSTANT PRIZE: (1:1) odds for Cash Cube entry once they open the new membership.
9. GENERAL CONDITIONS: Giveaway is open to all US residents, who are US citizens or legal immigrants. Participants must be at least 18 year of age to qualify for any of the prizes. Void where prohibited / restricted. All federal, state and local laws apply. Paying and reporting taxes (if any) are the winner’s sole responsibility. Prizes may not be substituted, transferred or exchanged, except at the sole discretion of Noble Federal Credit Union. Noble Federal Credit Union is not responsible for illegible, damaged, lost, late or misdirected mail entries, or game materials. All submissions become property of Noble Federal Credit Union. All game materials are subject to verification and are automatically void and will be rejected if any part(s) is forged, altered, defaced, tampered with, mechanically reproduced or modified, irregular in any way, irregularly obtained, or if they contain printing errors or omissions or are result of error. Should more prizes be claimed in any category than offered in the rules, Noble Federal Credit Union will substitute the winning prize with one of equal value. Alternative method of entry. For a chance to enter the Cash Cube during the Promotional Period without becoming a new member, submit a postcard to Noble Federal Credit Union Attn: Marketing 7 E. River Park Place E, Fresno, CA 93711. On the postcard include “Noble Cash Cube Promotion”, your name, phone number, and email address. Postcard must be received by November 14, 2025. One person will be selected from all postcards received to enter into the Cash Cube prior to November 21, 2025. Noble Federal Credit Union reserves the right to refuse any members who in their sole determination abuse their right to participate or violate the rules and to accelerate or modify methods of distribution if necessary.
